c. **Describe Requested Change in Detail:** DLA Transaction Services will need to change the DoDAAD Update and eDAASINQ.

(1) DoDAAD Update: DoDAACs that begin with "H96" will be reserved for USNORTHCOM's exclusive use.

(2) eDAASINQ: Create H96 series name in Service/Agency dropdown list as "US Northern Command (USNORTHCOM)" and select all DoDAACs beginning with H96.
