MEMORANDUM FOR SUPPLY PROCESS REVIEW COMMITTEE (PRC) MEMBERS

SUBJECT: Proposed Defense Logistics Management Standards (DLMS) Change (PDC) 1080,  
Intra-Air Force Requirement for use of Priority Designator in DLMS 527D  
Prepositioned Materiel Receipt (PMR) (Supply/MILSTRAP)

We are forwarding the attached proposed change to DLM 4000.25, Defense Logistics Management System (DLMS), and DLM 4000.25-2, Military Standard Transaction Reporting and Accountability Procedures (MILSTRAP), for evaluation and submission of a single coordinated DOD Component position. It is the responsibility of the Component Supply PRC representative to ensure full coordination of the proposal within your Component.

Request you review the attached proposed change and provide your comments/concurrence to DLA Logistics Management Standards Office not later than **30** days from the date of this memorandum. Air Force and DLA Transaction Services have immediate authorization to use these requirements by their mutual agreement, pending approval, with the understanding that the requirements may change depending upon staffing results.

## ATTACHMENT TO PDC 1080

### Intra-Air Force Requirements for use of Priority Designator in DLMS 527D Prepositioned Materiel Receipt (PMR) (Supply/MILSTRAP)

**1. ORIGINATING SERVICE/AGENCY AND POC INFORMATION:** Department of the Air Force, AFLCMC/ELS/HIAR, DSN 596-2012; Commercial (334) 416-2012

a. **Technical POC:** AFLCMC/HIAR, Integrated Logistics Solution – Supply (ILS-S)

b. **Functional POC:** AFLCMC/HIAR, ILS-S

**2. FUNCTIONAL AREA:**

a. **Primary/Secondary Functional Area:** Supply - This requirement is mandatory for all Pre-positioned Materiel Receipt (PMR) transactions originating from ILS-S (Air Force Retail Supply)

b. **Primary/Secondary Functional Process:** Supply Chain Visibility and Accountability

**3. REFERENCE:**

a. Defense Logistics Manual (DLM) 4000.25-2, Military Standard Transaction Reporting and Accountability Procedures (MILSTRAP)

b. Air Force Manual (AFMAN) 23-110

**4. REQUESTED CHANGE:**

a. **Background Information:**

(1) Air Force uses the priority designator data under the Defense Logistics Standard Systems (DLSS) in the MILSTRAP (Reference 3a) legacy Document Identifier Code (DIC) DW\_, PMR (Other Than Procurement Instrument Source) transaction field designated as multiuse for intra-Component data. Air Force cites the priority designator in DIC DW\_, record position (rp) 60-61.

(2) Priority Designator is identified in Air Force Manual (AFMAN) 23-110 (Reference 3b) for intra-Air Force use in rp 60-61 of MILSTRAP DIC DW\_.

b. **Description of Changes in detail:** This change request incorporates a data element in DLMS that is required to process accurately intra-Air Force data for the PMR. This change requests authorization for Air Force use of the Priority Designator (LQ01 qualifier 79) in DLMS 527D PMR.

c. **Procedures:**

(1) Revise DLM 4000.25-2 (MILSTRAP), Appendix 3.39 (DIC DW\_), to acknowledge Air Force data currently used in MILSTRAP multiuse fields designated for intra-Component use, in a footnote as follows (changes identified by ***bold red italics*** or double strike-through):

Multiuse	60-66	For intra-DoD Component use, enter data prescribed by the DoD Component. <sup>1, 2, 3</sup>

**STAFFING NOTE:** As an administrative update, the MILSTRAP Administrator is deleting existing DIC DW\_ footnote 3 (i.e., “Priority Designator is identified in Army Regulation (AR) for intra-Army use in rp 60-61”).  
**RATIONALE:** It is not necessary or appropriate to cite the Service publication information in a DOD issuance.

(2) Revise the DLMS 527D implementation convention (IC) as follows (changes identified by **bold red italics** or double strike-through):

**5. REASON FOR CHANGE:** Air Force receiving systems that interface with the Air Force retail supply system require the priority designator to be on the PMR transaction (DLMS 527D/MILSTRAP legacy DIC DW\_). The transaction fails when the priority designator is not present. Required for intra-Air Force use.

## 6. ADVANTAGES AND DISADVANTAGES:

**a. Advantages:** The major advantage to adding the priority designator to the transaction is that the 527D PMR transactions will process successfully for due-ins created in the Air Force receiving systems.

**b. Disadvantages:** If the priority is not present in intra-Air Force PMR transactions, the transactions fail and Air Force users have to manually process the transaction into the system. This manual processing causes delays in receiving critical weapon systems spares.

**7. ESTIMATED TIME LINE/IMPLEMENTATION TARGET:** Upon release of the approved DLMS Change.

**8. ESTIMATED SAVINGS/COST AVOIDANCE ASSOCIATED WITH IMPLEMENTATION OF THIS CHANGE:** Air Force cost avoidance is defined by the number of hours spent having to manually research, edit, and reprocess each line of data to add in the missing priority field since the Contractor Inventory Control Point (CICP) software flags that field as 'mandatory'.

## 9. IMPACT:

**a. New DLMS Data Elements:** None.

**b. Changes to DLMS Data Elements:** None

**c. Automated Information Systems (AIS):**

**(1) Air Force:** Changes as needed for intra-Air Force use of priority designator in 527D PMR under DLMS. The priority designator is already in use by Air Force systems using MILSTRAP legacy DIC DW\_ PMR transactions.

**(2) DLA and Services other than Air Force:** Proposed change is for intra-Air Force use only; no system impact to other DOD Components.

**d. DLA Transaction Services:** Requires update to DLA Transaction Services maps to document Air Force data mapping for priority designator between legacy DIC DW\_, rp 60-61 and DLMS 527D PMR (527D with 1/BR02/20 Transaction Type Code DE) for a mixed DLSS-DLMS environment.

**e. Non-DLA Logistics Management Standards Office Publications:** Air Force will update local Air Force policies as needed to document this DLMS requirement.
